4. Your Rights Under the DPDP Act

As a data principal, you have the following rights:

- **Right to Access:** You can request access to the personal data we hold about you.
 - **Right to Correction and Erasure:** You can ask us to correct inaccurate data or delete data no longer necessary.
 - **Right to Withdraw Consent:** You may withdraw your consent at any time. However, this may affect your ability to use parts of the Service.
 - **Right to Grievance Redressal:** You can contact our Grievance Officer for any data-related concerns.
